The fees for legalizations / certifications apply plus the respective consular fees as well as the authority fees, notary fees and / or translator fees, expense commissions in the Vienna area, paid by us. For obtaining notarizations outside of Vienna, shipping fees will be charged in addition.

Please note that we charge up to 65% of the invoice amount in significant advance (including consular, visa application center / provider, invitation, return shipping fees), and in this context a cash outlay fee of 4.9%.

Credit Card Payment - Credit card data is collected and managed for the payment process by the professional third party service provider Computop.

The contractor does not receive credit card data for security reasons.

Payment by direct debit - Creditworthiness provided - With your order you give us a direct debit authorization (= SEPA direct debit mandate). The invoice amount will be debited by us within 14 days after invoicing. Direct debits are only possible from an Austrian bank account. No transaction fee will be charged.

A price adjustment of third party services (including consular, visa application center/provider, shipping, invitation fees) can be made at any time during the contract period. The client will be informed immediately of any changes.
