Please note that we advance up to 65% of the invoice amount in significant upfront costs (including consular, Visa Application Center/provider, invitation, and return shipping fees) and charge a cash advance fee of 5.0% in this context.

Payment by credit card - Credit card data is collected and managed by the professional third-party provider HOBEX for the payment process. For security reasons, the contractor does not receive any credit card data.

Payment by direct debit – subject to creditworthiness - By commissioning us, you grant us a direct debit authorization (= SEPA direct debit mandate). The invoice amount will be debited by us within 14 days after invoicing. Direct debits are only possible within the EU, provided the executing bank is a SEPA participant.

A price adjustment of services provided by third parties (including consular, Visa Application Center/provider, shipping, invitation fees) can be made at any time during the contract term. The client will be informed immediately of any changes.
