The fees for legalizations/certifications are additional to the respective consular fees, as well as any fees advanced by us for authorities, notaries, and/or translators, and out-of-pocket expenses in the Vienna area.

Please note that we advance up to 65% of the invoice amount in significant upfront costs (including consular, Visa Application Center/provider, invitation, and return shipping fees) and charge a cash advance fee of 5.0% in this context. Payment by credit card - Credit card data is collected and managed by the professional third-party provider HOBEX for the payment process.

For security reasons, the contractor does not receive any credit card data.

Payment by direct debit – subject to creditworthiness - By commissioning us, you grant us a direct debit authorization (= SEPA direct debit mandate). The invoice amount will be debited by us within 14 days after invoicing. Direct debits are only possible within the EU, provided the executing bank is a SEPA participant.

A price adjustment of services provided by third parties (including consular, Visa Application Center/provider, shipping, invitation fees) can be made at any time during the contract term. The client will be informed immediately of any changes. Unless otherwise stated, prices are understood as net prices. Prices apply per traveler and per destination net, plus VAT, and are valid until revoked.
